


#### **Overview**

#### Workshop: Let's Get Angry!

What does it feel like to be angry in a courtroom setting? How do you defuse that anger? Experience what it is like to be a victim of the Reptile Theory, and learn the strategies to Slay the Reptile, as discussed in *Nuclear Verdicts®: Defending Justice for All.* Defusing anger is different than defending lawsuits. ## Keynote: Plaintiffs' **Psychological Warfare**

We know plaintiffs' attorneys are consistently strategizing ways to manipulate the jury, paint an unappealing picture of the defendant, and achieve a runaway jury verdict! During this session, learn the evolving tactics of a plaintiff attorney and discuss the proven strategies to overcome them.

### Syllabus: Trial Skills Sessions



#### Is It All My Fault?

Accepting responsibility is a vital step in defusing juror anger. During this session, you will gain valuable insights on how and why to accept responsibility. Discuss specific plaintiff strategies and themes, as well as how to combat them in the courtroom. You will learn how to tell your "responsibility story," be the most reasonable person in the room, and achieve justice for all.



#### **Behind Every Corporation is Just Another Person**

This session addresses the importance of personalizing the corporate defendant, putting a face on each corporate client, and how to do it. Personalizing a company through a corporate representative and weaving in the corporation's unique story throughout trial will defuse juror anger, make defense arguments more reasonable, and minimize the likelihood of a runaway jury verdict.



#### Give the Jury a Number

Giving a defense number in trial is imperative for stopping a nuclear verdict, and contrary to popular belief, does not preclude a favorable defense verdict. The jury actually appreciates a defense number! Through exploration of practical application and examination of case study examples, you will learn how to derive a defense number, when to introduce it, and how to reinforce it throughout trial.



#### You Want HOW Much?!

Arguing pain and suffering effectively is critical for defending against Nuclear Verdicts<sup>®</sup>. During this session, you will discuss how most defense attorneys typically argue pain and suffering (spoiler alert: they don't!). Learn why, when, and how to change your strategy, elevate your skills, and stop ignoring plaintiffs' open door to Nuclear Verdicts<sup>®</sup>. You will leave with specific methods for becoming the most reasonable person in the courtroom and closing the door on runaway jury verdicts.
